
**AFFIDAVIT OF THE GREENS AT ELKHART LAKE CONDOMINIUM ASSOCIATION, INC.**

I, Craig Cooper, the current President of The Greens at Elkhart Lake Condominium Association, Inc. (the "Association"), being first duly sworn, on oath state as follows:

1. The Association is the Condominium Association of The Greens at Elkhart Lake Condominium, Elkhart Lake, Wisconsin, consisting of tax parcels 59121586930, 59121586660, 59121586550, 59121586300, 59121586500 and 59121586450 (f/k/a Osthoff Greens Condominium) (the "Condominium").
2. The Association recently caused to be recorded the Restated Declaration of Condominium, dated January 7, 2025, and recorded on January 14, 2025, by the Sheboygan County Register of Deeds Office as Document No. 2173481 (the "Restated Declaration").
3. After recording, the Sheboygan County Register of Deeds informed me that the legal description used in the Restated Declaration erroneously referred to Unit 489, although Unit 489 does not exist in the Condominium.
4. Upon further investigation, there appear to be historical errors in the First Addendum of the Condominium Plat causing a discrepancy in Unit ID numbers and Unit Street Addresses, namely the condominium with an address of 489 Paulina Place was labeled Unit 493. The Association believes it was intended that this Unit be named Unit 489 to match the address, but the First Addendum was recorded with the scrivener error, and as such, the condominium located at 489 Paulina Place has become Unit 493.
5. I am aware that since the First Addendum, various other documents have been recorded with the legal description erroneously listing Unit 489.
6. Attached as Exhibit A hereto is the corrected legal description, replacing Unit 489 with Unit 493.
7. The purpose of this Affidavit is to clarify the record and correctly identify 489 Paulina Place as Unit 493.
